Type: Upholstery

Composition: 83% cotton, 15% polyester, 2% viscose

Yarn type: Staple / Filament

Binding: Jacquard / Velvet

Width: Approx. 140 cm, 55 inches

Weight: Approx. 580 g/lin.m, 18.71 oz/sq ft

Repeat: 70 cm Vertical / 70 cm Horizontal

Colour difference may occur

Cleaning: Vacuum clean frequently, ideally every week.

Remove stains as soon as they occur, with clean warm water or sparkling water. Extraction clean when necessary. Extraction cleaning might dissolve water based glue. Pay attention to temperature and amount of cleaning fluid.

Velour/chenille fabrics should be vacuumed in the nap direction.
